For multi-leg orders, RHS received a per contract rate of \$0.30, \$0.38, \$0.56, \$0.70, \$0.90 depending on the symbol's average spread. Differences in average payments among venues are due to the mix of symbols executed a teach venue. RHS attests to the retail nature of the orders RHS routes to third-party market centers bead on execution quality. The SEC Examination Staff has observed that there is a potential tradeoff between (i) payments received by brokers and (ii) price improvement and/or execution quality. RHS believes that the receipt of payment in the form of a portion of the spread earned by non-exchange third party market centers does not interfere with RHS' pursuit of best execution or the price improvement obtained on customer orders.

With respect to each section of this report, provided pursuant to SEC Regulation NMS Rule 606(a), the SEC has exempted broker-dealers from disclosing execution venues that received less than 5% of the non-directed orders covered by the section, provided that the section discloses the execution venues that, in aggregate, received at least 90% of such non-directed orders.
